4. If you need electricity for your booth please state so on your application. Failure to do so will put you in a spot where we may not have the space available to you and you may end up with a table with no electricity. You are also responsible for providing your own extension cord.

Money will be kept as a donation to The Anna Shelter. Also, Should you not notify us and not show up, monies will be kept as your donation to Tamarack Wildlife Center.
